Minutes of the meeting of the directors of the departments of veterinary medicine in Sharkia with the college administration and heads of standards and representatives of the Association of graduates of the Faculty of Veterinary Medicine Zagazig University

Within the framework of quality requirements and interaction of the college with representatives of the labor market, on Tuesday, 15/1/2013, a meeting was held for the directors of the departments of Veterinary Medicine in Sharkia with the college administration and heads of standards and representatives of the Association of Graduates of the Faculty of Veterinary Medicine Zagazig University. Before the start of the discussion, the college's accreditation was discussed. The Dean of the College, Dr. Amin, informed the College of Veterinary Medicine of the accreditation of the Faculty of Veterinary Medicine and the results of accreditation of the College. He pointed out that the accreditation visit to the College will be on 18-21 / 2/2013.

First: the opinion of the audience about the efficiency of the college graduates to work in the veterinary field

Some of the attendees said:

•College graduate does not have full experience and needs training courses to qualify for work in the veterinary field

•Despite the availability of modern methods of teaching and learning, but the old graduate is still the best and experience is gained from senior cadres

•There are deficiencies in the areas of surgery, complications, massacres, diagnostic laboratory tests and specialty pets

•The student is not ready to work in the massacres, as his aspirations to work in farms or pharmaceutical companies because of the high material compensation

•The percentage of female graduates is higher than males

•Some females are not psychologically qualified to work in the veterinary field. However, some females, especially rural women, are better than males

Proposals: Some participants suggested the following:

•The percentage of admission to the faculty should not be less than 25%

•Each student group should specify a graduation project as desired by the student (small research idea(

•Cancellation of the semester system and that the study is a full academic year because the student is under pressure examinations, which leads to the inability to collect well

Second: Summer training

Some attendees saw that the attendance of summer training students is not high. The student is not prepared to work in the massacres during training (he is not willing to hold the knife in the slaughterhouse(

Proposals: Some participants suggested the following:

•The summer training should be qualitative and not quantitative (in the form of specializations) where the wishes or tendencies of the students are different (eg poultry, genital care, surgery, labs etc.(.

•Activating the follow-up of students during the summer training by the administration and the college. There must be actual accountability from the college for those who do not attend and do not commit to following up the cases received and recording them well

•The training should be 6-12 months after the end of the final year examinations of the bachelor's degree

•Add pet and home specialty to summer training

•The attention to laboratory tests used in the rapid diagnosis of some cases such as hypophosphatemia - Tuberculosis -Brucellosis

•The College is in coordination with the Directorate for the work of veterinary convoys to be arranged in advance to collect cases and doctors to ensure the success of the convoy

Third: Training courses and scientific seminars

- The needs of veterinarians working in veterinary field from the training courses as follows:

•How small projects such as (rabbits, poultry farms, farms, small animals•

•Free training courses within the college hospital to activate the scientific side

•Courses on scientific innovations

•Fast diagnostic tools

•Project management and personnel management

•The field of domestic animals

•Surgery and procedures

- <sup>Y</sup>The establishment of specialized periodic seminars by the scientific departments of the college

•These seminars should benefit doctors in the new and inform the college of the problems that exist in the veterinary field

•Seminars should be held between the relevant scientific departments

•An invitation is sent from the table of seminars and panel discussions held in the scientific departments within the College to the Directorate of Veterinary Medicine and also posted on the site of the College and the site of the Association of graduates of the Faculty of Veterinary Medicine Zagazig University

- <sup>r</sup>Activating the role of the Association of graduates of the Faculty of Veterinary Medicine Zagazig University in cooperation with some competent authorities to work small projects

- <sup>£</sup>There are incentives to the Directorate of Veterinary Medicine and can be agreed between the College and the Directorate to grant these allowances to those attending the courses

Fourth: Graduate Studies:

- `Reasons for the reluctance of veterinarians working in the veterinary field to enroll in graduate programs

•Registration fees and letter costs

•The administration does not give full time to graduate students

•There is a difference between registered graduate students from abroad and staff assistants

•There should be free grants made by both the General Authority for Veterinary Services - the Guild - Contribution of the College Conference

•The Syndicate of Veterinarians intervenes in solving the problem of lack of full time for postgraduate students

•Work for the organization to follow up the regularity of graduate students and the notification of the employer

Fifth: Problems and general proposals

- \Linking the problems of the veterinary field with scientific research in the faculty: This is done through the address of the Undersecretary of the Ministry by the College to provide a statistical statement on the cases contained every 6 months and a statistical statement on the epidemics located in the province
